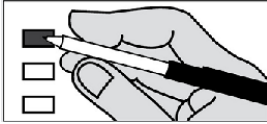

Any mark or writing outside of the spaces provided for voting may void the entire ballot. 3. The number of choices is listed for each contest. Do not mark the ballot for more candidates than allowed. If you do, your vote in that contest will not count. If you make a mistake, or you want to change your vote, contact an Election Official.
